Scholarship Submittal Requirements

The student is responsible for submitting all materials on time. Incomplete applications will not be evaluated.

- 1. Complete this application (*attach additional sheets if necessary*). Your name and address should be on all attachments. Completeness and neatness ensure your application will be evaluated appropriately.
- 2. Copy of your recent academic transcript.
- 3. Copy of your ACT and/or SAT exam scores. (Not required for scholarship consideration)
- 4. **Essay** – On a separate sheet of paper answer the following essay question. “Describe why you are interested in becoming a power line worker.”
- 5. **Letter of Reference** – Include a letter of reference from a teacher, school counselor, employer, youth leader or pastor.
- 6. Application must be signed by both the parent and the student in order to be considered.
